### ANNUAL MEETING OF THE OKLAHOMA HISTORICAL SOCIETY

April 24, 1980

The Eighty-eighth Annual Meeting of the members of the Oklahoma Historical Society was called to order at 10:15 a.m. by President Jack T. Conn in the Auditorium of the Historical Building on Thursday, April 24, 1980. President Conn introduced Robert Robbins of the Society's staff who sang the National Anthem accompanied by Virginia Armstrong. Mr. Conn commented he had never heard a more beautiful rendition. Rabbi Robert H. Rubin, Director of the B'nai B'rith Hillel Foundation in Norman was invited to give the invocation.

Executive Director H. Glenn Jordan was called to give an address, "State of the Society: The Future of the Past at the Present." He said that the Society will attempt to consult with regional and county societies throughout the state to offer them the services of the Oklahoma Historical Society in developing their various programs. He called attention to the 75th Anniversary of Statehood in 1982, the 100th Anniversary of the Run in 1989 and, somewhat later, the 100th Anniversary of Statehood in 2007. Mr. Jordan pointed out that since so much of Oklahoma's historical material is still available, the Society must collect, preserve and interpret the state's history within the next few years. He said the Society has a receptive Board, an understanding Governor, and a cooperative Legislature, all of whom will support the preservation movement in Oklahoma.

Mr. Jordan announced that Governor George Nigh has promised the Society \$600,000 for the next three years to be spent in developing the 75th Anniversary celebration.

Mr. Jordan praised Bruce Joseph, Education Director, for his efforts in planning the three-day Annual Meeting program and told of the work of Robert Robbins, who is also an exhibits designer, and Michael Roberts in preparing a study of a homesite in Hominy which may be given to the Society. Accountants Charles Reese and J. L. Armstrong were thanked for their work in the Finance Division and Mr. Jordan announced that Mr. Reese will become the Deputy Director of the Oklahoma Historical Society.

President Conn said that the success of any organization depends on one man and that the Society was most fortunate to have someone like Mr. Jordan with his drive and zeal as Executive Director, for neither the Board nor the Executive Committee can run the Society.

Dr. 'LeRoy H. Fischer was asked to present the Muriel H. Wright Endowment Award to Dr. Howard L. Meredith for his article appearing in Volume LVII, No. 3, Fall 1979, *The Chronicles of Oklahoma*, "Will Rogers' Roots." Dr. Meredith accepted the walnut plaque and \$300 stipend and urged the members to stress the teaching of Oklahoma's history in public schools.

Genealogist Mrs. John Moran was introduced to the members by Mr. Conn, who described the efforts of state genealogists in bringing to the attention of state legislators the need for more staff and security personnel at the Oklahoma Historical Society in order to provide 68 hours of service weekly in the Society's Division of Library Resources. Mr. Conn said a supplemental appropriation has been promised and that a proclamation commending the members of the Second Session, Thirty-seventh Oklahoma Legislature and the Chief Executive Officer of the State of Oklahoma for their action in providing the appropriation would be mailed to them. Senator Garrison moved to accept the resolution, Mr. Campbell seconded, and approval was unanimous.

After discussion regarding the matter of changing the location and days of the week of the Annual Meeting, Mr. Conn called for a vote of the membership. After the results were announced, Mr. Conn declared that the Oklahoma Historical Society would conduct its next Annual Meeting in Oklahoma City on Friday and Saturday, April 24–25, 1981.

Dr. Freddie Cudjoe, accompanied by June McKenny and Lance Cudjoe, Principal of the Oklahoma City Lincoln Fifth Year Center, presented a program of poetry and dance and illustrated by a slide presentation. The program was entitled, "Musical Moods in Black."

Mr. Conn then announced that because of the rain, the Bar-B-Que Luncheon would be held in the Auditorium, rather than on the South Lawn as had been planned.

The meeting adjourned at 11:15 a.m.

# MINUTES OF THE QUARTERLY MEETING OF THE BOARD OF DIRECTORS OKLAHOMA HISTORICAL SOCIETY

April 24, 1980

President Jack T. Conn called to order the quarterly meeting of the Board of Directors of the Oklahoma Historical Society at 1:30 p.m., April 24, 1980, in the Board Room of the Historical Society Building. President Conn asked Executive Director H. Glenn Jordan to call the roll and those responding were Mrs. George L. Bowman; Q. B. Boydstun; O. B. Campbell; Mr. Conn; Joe W. Curtis; Harry L. Deupree, M.D.; Mrs. Mark R. Everett; Dr. Odie B. Faulk; W. D. Finney; Dr. LeRoy H. Fischer; General E. Moses Frye; Nolen J. Fuqua; Senator Denzil D. Garrison; Dr. Donald E. Green; Colonel C. Forest Himes; Mrs. L. E. Hodge, Jr.; Ralph McCalmont; Earl Boyd Pierce; Jordan B. Reaves; Genevieve Seger; Britton D. Tabor; and H. Merle Woods. Miss Seger moved to excuse Dr. A. M. Gibson, John E. Kirkpatrick, and Mrs. Charles R. Nesbitt, all of whom had notifed Mr. Jordan they would not attend. Mrs. Bowman seconded the motion and approval was unanimous.

Miss Seger moved that the Board accept the gifts received during the quarter in the Library Resources and Museum and Sites divisions. Mrs. Bowman seconded and the motion passed unanimously.

Dr. Fischer moved that those 86 persons who had applied for membership during the quarter be accepted. Mr. Campbell seconded and the motion passed unanimously. Among those applying were new life members Armin Brandt, Mr. Conn, Zoe Davis, James L. Green, Jr., M.D.; and Dr. Paul F. Lambert, all former annual members.

Mr. Jordan presented for approval, additions, alterations or corrections the minutes of the Board meeting held January 24, 1980, and the Executive Committee meetings of January 21, February 20 and March 19, 1980. Mrs. Everett moved to approve the minutes, Dr. Fischer seconded, General Frye opposed approval of the minutes of the Executive Committee meetings, and all others voted to approve the minutes of Board and Executive Committee meetings.

One hundred persons had taken part in workshops held April 23 for regional and country historical societies, said Mr. Jordan, who announced that plans were being made to take similar workshops to regions throughout the state. Announcement was made of the supplemental appropriation bill which would enable the Oklahoma Historical Society to expand hours of service in the Research Library beginning May 5. Eleven new staff members would be hired to serve the public, including three security guards.

Mrs. Bowman introduced Charles Reese, Director of Finance and newly appointed Deputy Director of the Oklahoma Historical Society. Mr. Reese said he had analyzed the financial activities of the Society for the past ten years and would have a report for the Board members by May 30, 1980. Mr. Tabor moved, Dr. Fischer seconded, that the Board members be furnished a financial report a week prior to the quarterly meetings. The vote was unanimous.

Mrs. Everett, giving the Library Resources Committee report, referred to the eleven new positions authorized for the Division of Library Resources, the expanded library hours, and the De-accession List presented to the committee by the staff. Discussion followed on disposition of surplus books. Mr. Jordan said that many of the materials considered were originally from the Guthrie Carnegie Library and were sent to the Oklahoma Historical Society at the time that library was closed. Dr. Faulk asked that the chair appoint a committee of five to meet at the call of the Library Resources Committee to consider disposition of those books recommended by the staff for de-accessioning. President Conn appointed Mrs. Everett, Chairman of the Library Resources Committee; Senator Garrison and Dr. Gibson, members of the Library Resources Committee; Dr. Fischer; Dr. Green; and Mrs. Ruth Moran to the special committee.

Mrs. Everett, Chairman of the Black Heritage Committee, reported on the meeting of the committee held April 22. She said Mrs. Ann Covalt, Museum Director, had prepared a report for the committee showing that the special exhibit displayed in February had cost the Society nearly \$5,000. Mrs. Everett said that Representative Hannah D. Atkins would be requested to introduce a line-item appropriation for \$5,000 to be attached to the Society's appropriation bill for a Black Heritage Exhibit in 1981. An exhibit had already been secured from the Smithsonian Institute, as well as an exhibit in memory of Fred Douglas. Mrs. Everett requested permission to appear before the Executive Committee at the meeting scheduled for May 21. Permission was granted.

Mr. Jordan introduced visitors to the meeting—Ruth Moran, Ed Montgomery, Louis Copley, Elaine Willoughby, and Lloyd Lentz, III, who had recently joined the Oklahoma Historical Society staff as Director of the Division of Development.

Dr. Green asked Mr. Jordan to report on the status of the Lillie Morrell Burkhart case and the Elizabeth Phillips Irwin case. According to Mr. Jordan, John Akins, Assistant Attorney General, hoped to have a report on the cases to present to the Executive Committee at the May 21 meeting. Mr. Pierce asked Mr. Jordan to reveal the potential value of property to be received from the Burkhart estate. Mr. Jordan answered that the Oklahoma

Historical Society would receive 2.3 Osage headrights, estimated value \$60,000; 360 acres of open land; a house with 80 acres; and \$250,000 in cash. Staff members would prepare a theme development report of the Burkhart property and a study of Oklahoma Tourism and Recreation Department properties was being prepared to be presented in the fall.

Discussion followed on personnel problems at the Sequoyah Home site and Dr. Green moved, Dr. Faulk seconded, to support Mr. Jordan's solution to the situation. Vote was unanimous. Mr. Jordan reported that the two staff members at Fort Washita would reach retirement age in 1980 and new personnel would be hired for that site. Staff Archaeologist H. Marshall Gettys was assigned temporarily to Oklahoma City to the Division of Historic Preservation.

Mr. Boydstun reported that the Honey Springs Battlefield Park Commission had not met during the quarter, but that the Oklahoma Archaeological Survey would submit a study of the site to the Board by the July Board meeting. It had been suggested by the commission that an access road should not be constructed until the exact route of the old Texas road had been determined.

Mr. Boydstun presented a report on Fort Gibson, advising that the bake oven had been restored and the cover building completed—part of a development program proposed in 1979. Mr. Boydstun said that C. E. Metcalf, Director of the Division of Property Resources, and Bill Peavler, Architect, would go to Fort Laramie, Wyoming, to study that restoration. Mr. Boydstun reported that the Oklahoma Tourism and Recreation Department would meet with him at Fort Gibson to make a study of the restoration needs of the site.

A report was given by Mr. Boydstun of the original Army hospital at Fort Gibson, also known as the Garrett "House of History," which had been acquired by the late Judge Claude Garrett. The executor of his estate had offered to give artifacts to the Oklahoma Historical Society if it would purchase for \$175,000, the real property consisting of a building and vacant lot. Mr. Jordan said it would be necessary to have the the property inventoried and appraised by the probate court before a decision could be made.

Dr. Green in his report for the Guthrie Historic Preservation committee said that the committee had met during the quarter, although a quorum had not been present. He said the most pressing need was to attract investment capital to recycle the buildings in the downtown area to prevent their deterioration. Mr. Jordan added that he had met with representatives of the Guthrie Historic Preservation group and its administrator, Sallie Bodie, to work out a major plan for the development of Guthrie and the

State Capital Printing Building. He spoke of the cooperation he had received from preservation leaders in Guthrie, especially Mr. McCalmont. Mr. Pierce suggested that perhaps Oklahoma should center its preservation efforts in Guthrie, but Mr. McCalmont said that when he had come on the Board he had made a commitment to serve the entire state and felt that Dr. Green should be the Board sponsor for Guthrie preservation. Mr. McCalmont noted that few citizen groups had been given the stewardship of so many architectural relics as had those in Guthrie and said that the Oklahoma Historical Society would only be asked for assistance with specific problems on sites in which the Society was involved. Dr. Green said that he had conducted a tour for his students to the Guthrie area and they had expressed a desire to aid in the preservation effort there. They had planned to develop an architectural and usage history of the buildings and also discussed gathering enough data for informational plaques for each of the buildings to enhance the tourist value and suggested similar plaques for historic buildings throughout the state.

Mr. Jordan advised that he had received an invitation, as the State Historic Preservation Officer, to appear at the White House on May 15 with all other Preservation Officers. He said that what would happen in the Congress would dictate what would happen to federally funded preservation projects in Oklahoma. It was his opinion that Oklahoma could fund its entire preservation program but that the legislature had never had such a concept presented to them and therefore were not prepared to support a full preservation program at the present time.

Dr. Faulk reported on the progress of the Interpretation Division—continuing work on the Oklahoma Series, preparation of the cumulative index to the *Chronicles*, design and preparation of a history coloring book, initiation of the Pioneer Oklahomans Series, and issuance of news releases promoting Oklahoma Historical Society activities.

Colonel Himes reported that work was continuing on a leased building which would be used by the Property Resources Division as a workshop. He asked Mr. Jordan to give further information about the division's progress during the quarter. Mr. Jordan announced that the Society would receive a \$100,000 appropriation to be used for the acquisition of a permanent shop facility and that the Merit System had approved job descriptions for the Director and Assistant Director of the division. A photograph laboratory was being planned for the division and a photographer would be hired for the facility.

Mr. McCalmont yielded to Mr. Jordan for the report of the Development Committee. Mr. Jordan said he and Charles Reese were investigating private money for Oklahoma Historical Society development. Mr. James

O. Kemm, Executive Manager and representing the Oklahoma Petroleum Council, had informed Mr. Jordan that the Council had agreed to buy and deposit each year in the Oklahoma Historical Society library material pertaining to the oil industry. Spokesmen for the industry had expressed a concern for the preservation of such records and were considering the Society as the repository in Oklahoma for oil industry records. A need for an oil museum had also been expressed and Mr. Kemm had indicated that the Council would be very supportive of such a museum. Dr. Faulk moved that Mr. Conn write a letter to Mr. Kemm thanking the Oklahoma Petroleum Council for its generosity. Senator Garrison seconded and the motion passed unanimously.

Dr. Green moved to commend Bruce Joseph and the entire staff of the Oklahoma Historical Society for putting together a new annual meeting program. Dr. Faulk seconded and the motion passed unanimously.

Mr. Jordan requested the Board to extend officially the tremendous thanks of the staff to Dr. Deupree for his kindness in opening his home for a reception for staff members and spouses to meet with Dr. Gerald George, Executive Director of the American Association for State and Local History. The reception was held in conjunction with the Annual meeting. Dr. Faulk and Mrs. Bowman seconded and the motion carried unanimously.

Mr. Jordan noted that he had compiled a history of historic preservation based on a paper written by Robert M. Utley, former administrator of the United States Park Service, presented at the conference for State Historic Preservation Officers in San Antonio. Mr. Jordan said he felt it was the clearest definition he had seen of historic preservation and that his compilation was appearing in the April/May issue of Oklahoma Gazette.

Mr. Jordan conveyed a request from the Executive Committee to the full Board to consider the question of membership dues. The committee had recommended an increase from \$5.00 to \$10.00 per year. Such an increase would mean a yearly \$20,000 increase in income for the Society. The committee had also requested that the life membership fee be increased from \$100 to \$150. Dr. Faulk and Dr. Fischer urged that the recommended increases be made as soon as possible and asked that they be considered at the July meeting. Dr. Fischer said that a future issue of the monthly newsletter, *Mistletoe Leaves*, would carry an article about the proposed dues increase.

Mr. Jordan invited all Board members to attend the dedication following the Board meeting of the Delmar Garden monument, newly erected at the Oklahoma City Public Market. Mr. and Mrs. Byron Gambulos had donated the monument and were hosting a reception at the site. Mrs. Gambulos was

the daughter of Pete Sinopoulo, one of the founders of the early-day Oklahoma City amusement park.

Dr. Faulk moved to adjourn, Dr. Fischer seconded, and adjournment came at 4:30 p.m.
