A Page in Oklahoma History

An Eyewitness Account of the Constitutional Convention

From November, 1906, to April, 1907, the Constitutional Convention met at Guthrie, Oklahoma Territory, when Stuart Bryan was a thirteen year-old page boy. Bryan, an alert eighty-eight year-old gentleman, remembered the event clearly, including the word "Con-Con," short for Constitutional Convention.

Stuart Bryan was born in Florida, July 20, 1894. In 1901 he and his family moved to Shawnee, Oklahoma Territory. Before leaving Shawnee in 1909, he attended Sacred Heart School near Shawnee and the Preparatory Territorial School at Tonkawa, Oklahoma Territory. His father, Milton Bryan, a lawyer and territorial representative, served on the last Territorial Legislature and the first State Legislature. Senior Bryan was a good friend of William "Alfalfa Bill" Murray.

Many boys, including Stuart Bryan, wanted to be a page boy at the Convention. It was through his father's friendship with Bill Murray that the boy was appointed. Passing years have not dimmed the memories of that Convention for Mr. Bryan.

The hall at Guthrie housed about 100 delegates, plus a large number of spectators. Mr. Bryan does not know the exact number of page boys, as he did not meet all of them. As far as he knows, he is the last survivor. The boys did not wear uniforms.

His duties were numerous. They included taking notes to the speakers, delivering newspapers, and running errands. Many of the members ate popcorn, and he was kept busy supplying them with the snack.

The one-time page boy recalls that "Bill" Murray was a tough, smart opponent. Peter Hanraty was the vice president and John M. Young was the secretary. Charles N. Haskell, later the first governor of the new state, was often on the floor.

Many arguments became so heated that fist fights resulted. William A. "Bill" Durant, as Bryan remembers, was the sergeant-at-arms. A tall good looking Indian, Durant quickly controlled any uprising, and had the men shake hands and return to work.

Once, during a slow time, the members of the Convention had the page boys speak before the delegation. Mr. Bryan says the boys did not know what they were saying as the men "put big words into our mouths." It was a fun time. Later pictures were taken.

The Santa Fe Railroad kept a locomotive, steam up, at the Guthrie railroad station. This was used to transport the legislators to Oklahoma City. Once, when the train was to take some of the members to Oklahoma City, Stuart Bryan wanted to go, but his father was too busy to take him. Murray was aware of this, so he patted the boy on his head and said, "I'll take young Bryan." Stuart Bryan went to Oklahoma City and sat next to Murray on the speakers' platform. As Stuart now says, "I was the biggest man in the hall!"

Under Murray's guidance, the delegation hammered out the State Constitution. When it was finished, Bryan recalls, Guthrie had a big celebration. The dress varied, ranging from overalls to frock coats and gowns. The smell of mothballs filled the room. A ceremony marking the marriage of Oklahoma Territory and Indian Territory was held on the Carnegie Library steps. In September, 1907, Charles N. Haskell was elected the first state governor, defeating Frank Frantz, the last Territorial governor. Until 1910 Guthrie was the capital of Oklahoma. Mr. Bryan was in Oklahoma City when Governor Haskell moved the state seal to Oklahoma City. The first temporary capitol was the Lee-Huckins Hotel. Before the final removal to the new state capitol, government offices were housed in several city buildings.

As might be expected, many cities were competing for the capital. These included Capitol Hill, Oklahoma City, Putnam City, and Mr. Bryan's home town of Shawnee. I. M. Putnam, an active realtor in Oklahoma City, was a strong campaigner for the Putnam City location.

Putnam built a block of brick-front buildings west of Oklahoma City. At one end he erected a three-story brick hotel, which is now part of the Putnam City Junior High School. He made arrangements with John Shartel, a promoter of street car lines, to build and have regular one-half hour service to that city. Bryan's father was a secretary for the I. M. Putnam Co. The boy often went with his father on visits to the Putnam residence.

One evening when they were attending a dinner at the Putnam Hotel, Putnam offered the state 100 acres for a silver dollar if Putnam City were selected as a site for the state capitol. Stuart remembers that Putnam pointed to the tract.

Governor Haskell had selected a committee of men to decide upon the location of the future capitol. Because of Putnam's influence in the legislature, Putnam felt his offer would not be refused. At a later dinner which Stuart and his father attended, the news of a contrary selection leaked to Putnam before the public announcement. It was to be at N. E. 23rd Street and Lincoln Boulevard. Putnam, as Bryan remembers, constantly paced the floor at this turn of events.

Instead of politics, Bryan entered the Department of Agriculture. He retired in 1951. In 1982, age 88, he was quietly retired in Oklahoma City. Years had dimmed his sight, but he remained an avid reader. As a member of *The Talking Books*, he "read" many books a year. In conjunction with this program, he listened to station KJYOFM, which broadcast daily programs beamed to persons with sight problems.

At the time of this interview, Bryan's mind was sharp concerning the events of the Convention. He often chuckled as he recalled the antics of the delegates during the Constitutional Convention at Guthrie, Oklahoma Territory, in 1906 and 1907.
