Minutes of the Annual Meeting of the Oklahoma Historical Society

April 26, 1985

President Denzil D. Garrison called the Ninety-third Annual Meeting of the Oklahoma Historical Society to order at 1:00 p.m. in the auditorium of the Wiley Post Historical Building. He called upon Colonel Roy P. Stewart to lead the pledge of allegiance to the flag. Vice President Ralph McCalmont then gave the invocation.

President Garrison invited any member present who had not voted previously, to vote in the election to fill the expiring seats on the Board of Directors. He declared the polls closed and asked Jack Haley, chairman of the Nominating Committee, to complete the tally of the votes.

Executive Director C. E. Metcalf was introduced by President Garrison who expressed his appreciation for Mr. Metcalf's exemplary leadership during the past few years. In his annual report, Mr. Metcalf first explained that because of financial restraints placed on the agency during the year, the agency had taken the opportunity to process, inventory and catalog its research, archival and artifacts collections. He announced that Mary Lee Boyle, Senior Archivist, would present later in the meeting a detailed report of the work of the Archives and Manuscripts Division. Mr. Metcalf gave an account of the Administration and the Finance divisions, noting that the Finance Division had performed well while working under new regulations from the Office of State Finance, the Office of Public Affairs and the Office of Personnel Management. An increase in paperwork and control had resulted from the regulations. He added that the Society had approximately \$1,000,000.00 invested in various banking institutions and earning the market rate of interest. The Burkhart Estate was included in the investments.

Mr. Metcalf told of gifts and grants received by the Research Library Division. Of major benefit he said, was a federal grant through the Oklahoma Department of Libraries for the installation of the Online Cataloging Library Center (OCLC). The system freed the technial staff from cataloging tasks, thus allowing them time to perform more complex work. A record number of researchers (26,279) had signed the register the past year and the OCLC unit will make it possible for the staff to better assist the public in the future.

A Samual Roberts Noble Foundation grant had made possible the continuation of microfilming the state newspaper backlog. Mr. Metcalf said the grant would permit the vital project to continue through December, 1985.

A major gift of 396 books pertaining to the Civil War was donated to the Research Library by Eugene Bray, Paris, Texas, former chairman and member of the Fort Towson Commission. There were also purchases of 341 books and 437 rolls of microfilm from the National Archives Trust Fund Board (the 1900 federal census of states adjoining Oklahoma) during the year, said Mr. Metcalf.

Mr. Metcalf expressed his regret in reporting the resignations of Library Director Andrea Clark and Library Public Area Supervisor Charlesa Timmons.

Changes had also taken place in the Museums and Sites Division, said Mr. Metcalf.

Program development had to be somewhat curtailed, but a matching grant from the National Endowment for the Arts and the Noble Foundation had enabled the division to contract the restoration of the Teton Dakota tipi by Ethnographic Conservator Mayda Goodberry, Blair, Nebraska. A Plains Indian exhibit was being developed in the South Gallery to accommodate the tipi. In conjunction with the restoration, a symposium on Plains Indian Pictographic Art, featuring well-known Plains Indian scholars, had been scheduled for May 15–16, 1985.

The Wiley Post Historical Building had experienced a "good news, bad news" year, said Mr. Metcalf. A central heating and cooling system had been installed, benefiting researchers, staff and the Society's irreplaceable collections, but severe water damage had occurred in the East Gallery from a leak in the roof of the building while new roofing was being installed. The contractor had been reluctant to take responsibility for repairs and litigation was a possibility before the gallery could be re-opened.

A number of the Society's 28 museums and sites had taken part in a "Museums Assessment Program" sponsored by the American Association of Museums. It was hoped that the assessment would point out some needs and directions for the facilities.

Staff turnover in the Museums and Sites Division was relatively high, said Mr. Metcalf. One employee had retired, one had changed positions within the agency, and six staff members had resigned to accept other employment. One of these was Museums and Sites Director Mac R. Harris.

The staff of the Historic Preservation Division was commended by Mr. Metcalf. He described their administration of the federal progams: funding for ten National Register Properties Rehabilitation projects (the Emergency Jobs bill fund)—the first development funds available since 1980. Tax credit programs, some fifteen in all, were completed (fourteen of those were in the Guthrie Historic District). A total of 31 projects had been evaluated.

The division processed two requests for the Certified Local Government program (CLG), which endeavored to assist local governmental entities in assuming a larger role in qualifying or evaluating historic places/buildings in their own localities. The program had received little response nationally, said Mr. Metcalf, who also served as the appointed State Historic Preservation Officer. Through the efforts of the staff, the local governments of Enid and Guthrie were being certified. The Third Annual Vernacular Heritage Conference was hosted by the division, said Mr. Metcalf, noting that the conference had been held the day before the Society's Annual Meeting.

The Historic Preservation staff had published several articles in "Westview," on National Register Properties. Staff members who contributed to the Southwestern Oklahoma State University publication were Deputy State Historic Preservation Officer Melvena T. Heisch, Marshall Gettys and John Hill. In addition, "Oklahoma Today" had featured Preservation Architect Bill Peavler's article on the University of Oklahoma's Crystal Chapel.

Mr. Metcalf continued his report stating that Publications and Education Director Bob L. Blackburn and his staff had published many books and brochures in addition to The Chronicles of Oklahoma and "Mistletoe Leaves." Some of them were Oklahoma Land Run of 1889, Stan Hoig; The West Wind Blows, E. E. Dale Autobiography; and Images of Oklahoma, Bob L. Blackburn.

A two-year project to index "The Daily Oklahoman" and its predecessors was initiated, with funding provided by the Oklahoma Publishing Company.

Another program described by Mr. Metcalf was the Oklahoma Historical Resource Center, funded by the Legislature, and inaugurated in Holdenville and Buffalo public high schools.

Book and sale items marketing had resulted in an average monthly sales volume of 326

\$6,000.00, with sales in November and December totalling \$11,000.00 each month, said Mr. Metcalf.

Mr. Metcalf prefaced his closing remarks with the announcement of the resignation of Louis Coleman, Deputy Executive Director. Mr. Metcalf said that with Mr. Coleman's attention to detail, the support of the Board of Directors and his own philosophical bent, he believed that all were coming to a good understanding of the mission of the Society. He thanked the membership, the Board of Directors and the staff for their efforts in making the year a successful one.

President Garrison called upon Dr. LeRoy H. Fischer to give a report of the Membership Committee. Dr. Fischer announced the committee's goal to increase the membership by 1,500 by 1986. He expressed the need for members who would work to increase the awareness of history through all of Oklahoma.

Each year at the annual meeting, one division of the Society was featured to inform the membership of its function within the agency. The Archives and Manuscripts Division had been chosen and President Garrison introduced Mrs. Boyle to describe the work of that division. She recalled that the division was organized in March of 1934 under the direction of Rella Looney. At that time, Congress had given to the Oklahoma Historical Society the state Indian records consisting of three million single document pages and five thousand bound volumes. Mrs. Boyle said that few realized the Society was one of only three respositories in the country holding federal records: military records at West Point, Spanish land records in Arizona and Indian tribal records at the Oklahoma Historical Society. She informed the members that the Society's photograph archives and the oral history project had been transferred to the Archives Division in 1981. In 1976, \$90,000.00 was received to microfilm the Indian and other records. Mrs. Boyle thanked the Board and the staff for their support throughout the year.

Mr. Haley of the Nominating Committee was asked to announce the results of the election of new directors. Those elected were Dr. Brad Agnew, Tahlequah, District Two; Brunetta B. Griffith, Rush Springs, District Four; and Donald L. Coffin, Guthrie, and Ruth Eager Moran, Oklahoma City, at large. Dr. Fischer moved that the report of the Nominating Committee be accepted. Ben Blackstock seconded and acceptance was unanimous.

President Garrison thanked those directors leaving the Board: O. B. Campbell, Vinita, District Two; Dr. Robert V. Peterson, Norman, District Four; and Edna M. Couch, Norman, and Mrs. Charles R. Nesbitt (who had chosen not to run for reelection), Oklahoma City, at large.

Mrs. Lucille Warrick moved, seconded by Ms. Couch, that the list of Oklahoma Historical Society Board of Directors be printed in *The Chronicles of Oklahoma* and "Mistletoe Leaves," designating the district or at-large position each director represented and whether the position was an elected or appointed one. Members present approved the motion.

President Garrison announced that a program entitled, "Preserving Historical Resources in Your Community," would be presented following the meeting. The progam was provided by the Historic Preservation Division and all were invited to attend.

There being no further business, President Garrison declared the Ninety-third Annual Meeting adjourned, expressing the hope that he would see all those members present at the Annual Banquet and awards program which was to be held at 7:00 p.m. that evening at the State Capital Publishing Museum, Guthrie. The banquet was to be served by the catering firm, Feedlot II, of Fairview.

Minutes of the OHS Quarterly Board Meeting

April 26, 1985

Following the Ninety-third Annual Meeting of the Oklahoma Historical Society, the quarterly meeting of the Board of Directors convened at 2:25 p.m. President Denzil D. Garrison invited the newly appointed and elected members of the Board to come forward to receive the oath of office administered by Supreme Court Justice Yvonne Kauger. The members appointed by Governor George Nigh were John Massey, Durant, District Three, who could not be present; Jack T. Conn, Oklahoma City, District Five; Dr. LeRoy H. Fischer, Stillwater, and Denzil D. Garrison, Bartlesville, at large. Elected members were Dr. Brad Agnew, Tahlequah, District Two; Brunetta B. Griffith, Rush Springs, District Four; Donald L. Coffin, Guthrie, who could not be present, and Ruth Eager Moran, Oklahoma City, at large.

President Garrison reminded those present that outgoing members of the Board were given emeritus status and he asked for a motion to declare the following members emeritus of the Board: O. B. Campbell, Edna M. Couch, Mrs. Charles R. Nesbitt and Dr. Robert V. Peterson. Dr. Fischer seconded and approval was unanimous.

Executive Director C. E. Metcalf was asked to call the roll. Those responding were Dr. Brad Agnew; Dr. W. David Baird; Edna H. Bowman; Jack T. Conn; Dr. Odie B. Faulk; W. D. Finney; Dr. LeRoy H. Fischer; President Garrison; Dr. Donald E. Green; Brunetta B. Griffith; Colonel Martin A. Hagerstrand; Jack D. Haley; Berenice Jackson; James O. Kemm; Ralph McCalmont; Ruth Eager Moran; Zella J. Patterson; Jordan B. Reaves; Lewis R. Stiles, D.V.M.; Ellen K. Walcher; and Lu Celia Wise. Ben Blackstock, Q. B. Boydstun and John Massey had asked to be excused. Donald L. Coffin was unable to be present.

Mr. Metcalf presented for approval the minutes of the Executive Committee meetings held January 17, February 20 and March 20, 1985; of the quarterly meeting of the Board of Directors held January 23, 1985; and of the minutes of the meetings of the Burkhart Trustees (the Executive Committee served as trustees) January 17, February 20 and March 20, 1985. Dr. Green asked for an amendment of the minutes of the quarterly meeting. He said that paragraph three, page nine, should be corrected to read: "... from one to one and one-half pages of cases whereas the State of Oklahoma had thirteen pages of cases." (The words "boxes" and "documents" were incorrect.) The first paragraph on page ten should be corrected to read: "... the fee for microfilming would be approximately \$25.00." Dr. Green moved that the minutes be adopted as amended; Dr. Fischer seconded, and approval was unanimous.

The gift lists from the Museums and Sites Division, the Library Resources Division and the Archives and Manuscripts Division were presented by Mr. Metcalf for approval. Mrs. Bowman so moved, Dr. Green seconded, and acceptance of the gifts was unanimous.

Three hundred persons had applied for membership in the Society during the quarter, said Mr. Metcalf. Mrs. Wise moved to accept the applications, Mr. Conn seconded, and the applications were accepted unanimously.

Mr. Metcalf presented the old business report. Mr. Conn moved to accept the report, Mr. McCalmont seconded, and approval was unanimous.

Treasurer Fischer had requested Finance Officer J. L. Armstrong, Jr., to describe the yield on Special Account No. 1350B, which currently was earning nine percent and totalled over \$1,000,000.00. Dr. Fischer moved, Dr. Green seconded, that the Treasurer's report be accepted. Approval was unanimous.

Dr. Fischer presented the report of the Publications and Education Committee. He reviewed the publication efforts of the division, noting that in addition to production work on future issues of *The Chronicles of Oklahoma* and "Mistletoe Leaves," work had also progressed on *Oklahoma*'s Governors, 1955 to 1979, Twentieth Century Indian Policy, A Short History of Oklahoma and County Courthouses of Oklahoma. Dr. Fischer distributed copies of the division's "Oklahoma History . . . A Past Preserved," a brochure presenting a short history of the state and a map of the museums and sites of the Oklahoma Historical Society. Mr. Haley moved to accept the report of the committee. Mrs. Bowman seconded and acceptance was unanimous.

Mr. Campbell prefaced his report of the Museums and Historic Sites Committee by suggesting that donors of gifts to the Society be sent a personal letter of appreciation in addition to the required gift agreement form. He presented loan requests from the Kirkpatrick Center for a photograph of Willie Murray; from the Oklahoma Amateur Athletics Association for some plaques which had formerly hung in the State Capitol; and from Wesleyan College, Bartlesville, for loan of a piano from the Frank Phillips Mansion. The piano was being replaced by the donation of an older instrument which had originally been in the mansion. The committee had approved the loans to Wesleyan College and Kirkpatrick Center but deferred action on the request from the Amateur Athletic Association since they lacked a suitable facility to display the plaques.

Mr. Campbell announced that the restored Teton Dakota buffalo hide tipi would be on display in May and that a Plains Pictographic Art Symposium would be presented May 15–16, 1985.

Mr. Reaves called attention to a potential crisis in management in the Museums and Sites Division, noting that Deputy Executive Director Louis Coleman was resigning June 30, the director of Museums and Historic Sites Mac R. Harris had resigned and that Mr. Campbell, chairman of the committee was leaving the Board. Mr. Campbell took the opportunity to express his appreciation for the chance to have served on the Board of Directors since 1971. Mr. Reaves moved, Dr. Fischer seconded, that the report of the committee be adopted. Approval was unanimous.

Dr. Baird presented the report of the Archives and Manuscripts Committee. The division had given an account to the committee of the processing and accessioning of manuscripts materials and photographs, and of the microfilming of various tribal files and records. Dr. Baird said 616 researchers, including Dr. Donald Berthrong and Dr. Elizabeth Tooker, had used the facilities during the quarter and research assistance had been given to a number of the members of the news media. Dr. Faulk moved to accept the report; Dr. Green seconded and acceptance was unanimous.

Mr. Haley said that during the meeting of the Library Resources Committee much discussion had taken place regarding the completion of the project to microfilm the backlog of state newspapers. He announced that Mr. Blackstock had been appointed to take charge of the project and would meet with Mr. Metcalf and Mary Moran, newspaper librarian. Mr. Haley said the staff would present a report of lost or misplaced materials and would also be working on a review of the collection development plans and a revision of the de-accessioning policy. Mr. Reaves moved that the report of the Library Resources committee be adopted; Mrs. Ruth Moran seconded and all were in agreement.

Dr. Green commented on the lack of space for researchers in the library, noting that space available was utilized to the maximum with microfilm readers. He said he knew that history students could not get to the readers, and therefore were not using the Society's library, some leaving history studies altogether. Mr. Haley said the matter

had been discussed but that no solution was available at that time. He welcomed suggestions.

Mrs. Patterson presented the report of the Black Heritage Committee. She said thirty repondents had completed forms evaluating the Black Heritage Genealogical Workshop held in February and noted that there was an interest in continuing such workshops, although she said Jack Wettengel of the staff had recommended that the committee only provide guidance for such progams, rather than becoming actively involved. The committee considered the need for a fund-raising project to finance the Honey Springs Battlefield Marker, which was estimated to cost \$2,000.00 or more. Another marker which the committee was sponsoring was the Breaux Marker in Oklahoma City's Washington Park. Mrs. Patterson said the Oklahoma City Park Commission had been asked to build a bandstand near the marker.

Themes for Black Heritage Month 1986 were discussed, with the committee agreeing on the theme, "History of Black Settlement in Oklahoma." Mrs. Patterson reported that the final consideration of the committee was the development of a plan to spread Black Heritage activities throughout Oklahoma, rather than confining efforts to the Oklahoma City area. Mr. Haley moved that the committee report be accepted; Dr. Faulk seconded and acceptance was unanimous.

Colonel Hagerstrand said the Historic Preservation Committee had been given a report concerning the Certified Local Governments Program which involved local communities in direct participation in historic programs of federal and state governments. He said requests for certification had been received from Enid and Guthrie.

The Third Annual Vernacular Heritage Conference was held April 25 and approximately fifty persons had attended. Ten panelists presented subjects ranging from Work Projects Administration architecture and architecture of the Wichita Mountains Wildlife Refuge to Osage peyote churches.

During the quarter the staff had been involved with fourteen new or in-progress projects under rehabilitation for the 25 percent federal investment tax credit, a rate higher than previous years, according to Colonel Hagerstrand. Individual subgrant project applications were submitted to the National Park Service for various creeks and rivers and a historic/architectural survey was conducted in cities in the northeastern quadrant of the state. Colonel Hagerstrand moved that the report of the committee be adopted; Dr. Green seconded, and adoption was unanimous.

Mrs. Wise reported that the Indian Heritage Committee was attempting to contact representatives of all Indian tribes in the state to acquaint them with the goals of the committee. She said that 75 presentations had been given over the past six months under the auspices of the Tulsa Arts and Humanities agency. The programs usually presented the mock wedding of Miss Indian Territory and Mr. Oklahoma Territory. Another effort supported by the committee was the organization of Indian women artists, "The Daughters of the Earth." She moved that the report of the committee be approved; Dr. Stiles seconded, and approval was unanimous.

The Membership Committee report was presented by Dr. Fischer. He paid tribute to Ms. Couch for her efforts in contacting members of the 1889ers Association to encourage them to join the Okahoma Historical Society. Mrs. Moran said she was inviting the members of the Oklahoma Genealogical Society to join the Society and President Garrison said he had mailed invitations to members of the legal profession. Mr. Reaves suggested that the agency's surplus publications could be offered as membership incentives. Dr. Fischer moved, Mr. McCalmont seconded, that the report of the committee be approved and approval was unanimous.

Mr. Metcalf presented his amended proposal for staff realignment. He said final

implementation would depend on legislative funding and outlined staffing needs of the agency, noting that had it not been for the Noble Foundation grant, only one microfilm camera could have been assigned to the newspaper backlog project. He said because of staffing limitations, capital improvement monies could not be properly expended in a timely way and referred to the number of sites and museums operated by the Society which could not be maintained and developed in an orderly fashion. He suggested that the Board members coordinate requests to the legislators through President Garrison to call attention to the financial needs of the Society. Colonel Hagerstrand moved, Mrs. Wise seconded, to approve the report.

Following a discussion on the proposed organizational chart, Colonel Hagerstrand moved that the words "Museums and Sites" under the Deputy Director title be stricken; that the title "Supervisor" be changed to "Director" of Museums; that the title "Manager" be changed to "Director" of Historic Sites; and that the three remaining sections under the Deputy Director be listed only as "Property Resources," "Sales" and "Central Services." Dr. Fischer seconded the amendments to the organizational chart, and approval was unanimous. To a question from Dr. Green, Mr. Metcalf explained that the rationale for placing the three sections under the Deputy Director was that the Deputy Director could be the liaison for maintenance and construction work unrelated to the other sections. The Executive Director was asked to prepare a complete organizational chart of the agency for the next meeting of the Executive Committee.

Mr. Haley expressed his appreciation to Louis Coleman, Deputy Executive Director, for the service he had rendered to the Board and the Society over the past three years. Dr. Green added that Mr. Coleman had just completed his Master's thesis under his supervision. Dr. Green said the thesis, "Cyrus Byington, Missionary to the Choctaws," was probably the best thesis ever submitted to him as Chairman of the History and Geography Department at Central State University. Dr. Baird observed that Mr. Coleman was both a scholar and an administrator and that there would never be a replacement for him. All agreed.

Dr. Baird announced that Friday, May 10, was State History Day. He extended a statewide invitation to those present to attend the contest which was to take place at the State Capitol at 9:00 a.m. The Oklahoma Historical Society had given support to the program, said Dr. Baird, noting that news coverage was not as great in Oklahoma City as in Tulsa, making the Society's involvement even more appreciated. Dr. Baird also noted that he had visited historic sites in southeast Oklahoma and had had trouble locating them because of the poor condition of directional signs. At one time, the Highway Department had a special appropriation to erect the signs but such an appropriation to maintain them was not presently available to any agency, Mr. Metcalf said

Colonel Hagerstrand suggested that the Vernacular Conference be made a part of the annual meeting and he urged that such efforts go forward.

Colonel Hagerstrand informed the directors of Mr. Boydstun's illness. He told them of the urgent need for funds to purchase the Hospital on the Fort Gibson Military park grounds. He said the purchase price of \$58,000.00 would soon be due and that he had talked with the Senate and House leaders who had indicated that, subject to the passage of the state question on budget, there would be money put in the Society's appropriation bill for purchase of the Hospital and the Adjutant's Office. Colonel Hagerstrand noted that if the properties were not purchased soon, Mr. Boydstun would lose the \$5,800.00 he had personally deposited for that purpose.

Mrs. Jackson suggested that Joe Todd, the Society's oral historian, contact anyone who might recall Black Sunday, April 14, 1935. Mr. Todd had already started developing interviews with World War II veterans.

Ms. Couch, outgoing Board member, called attention to the requirement in the Society's bylaws that the Nominating Committee should consist of one member from each district and that committee members should rotate each year. She expressed her pleasure at having served on the Board during the time when both Mr. Metcalf and Mr. Coleman were selected.

There being no further business, the meeting adjourned at 3:00 p.m.
